In order to apply and retain a purchasing relationship with PHbotanical inc., all prospective and existing customers must meet and maintain the following requirements. These requirements are effective January 1, 2015.

All orders will be placed online at office@picketthouse.com Email address will be required.

Opening order is \$800.00 (wholesale cost) minimum. Opening and minimum orders must be regular product. Reorder \$200.00 (wholesale cost) minimum.

All wholesale orders must be ordered in case quantities of 12. ***with the exception of 6 per case for *NIGHT skin care, 50 per case of *Lib balms. Excluding back bar orders.

Shipping and Handling charges will be added to your invoice. Please give us a call at 941-444-7180 for questions about this.

Payment is required before your order is shipped. We accept Visa, Master Card, and Discover.

Orders are shipped within 2 business days after the order is handmade. Please allow extra time for your order to accommodate this or back bar items.

Claims: Breakage must be reported within 2 business days of your order being received. We pack our items as carefully as possible, but occasionally something may arrive damaged. If that happens, please retain all original packing material, take photos, and call us at 941-444-7180 for instructions on receiving your replacement items.

Restock fee of 25% on shipped orders that are not accepted. Wholesale Customers are liable for shipping and handling charges on all returned/refused orders.
